MUSICIANS' RESPONSIBILITIES

Musicians are expected to learn and model <u>NVYS Code of Conduct</u>, follow all rules and demonstrate appropriate social skills when interacting with both adults and peers during NVYS/Sinfonia rehearsals, concerts and events. When behavioral expectations are not met, the musician is expected to work to improve behavior.

1. BE SAFE

- I am responsible for maintaining safety at rehearsals, concerts and events.
- I engage in activities that are safe and report any known safety hazards.
- I help maintain a clean and safe rehearsal and concert space that is free of graffiti, weapons, and drugs.
- I report any bullying or harassment.
- I avoid conflicts and physical or verbal violence.

2. BE RESPECTFUL

- I treat others the way I want to be treated.
- I respect NVYS rules and NVYS staff, Directors, Conductors and Adult Volunteers, as well as Napa Christian Campus of Education staff.
- I treat people fairly and respect their rights.
- I respect private and public property.
- I support my colleagues' musical and personal growth.
- I am honest and with myself and others.
- I avoid spreading rumors or gossip.
- I respect each person's right to be different and I look for the good in others.

3. BE RESPONSIBLE

- I take responsibility for my actions.
- I choose how I respond to others.
- I give my best in rehearsals and concerts.
- I come to rehearsal regularly and on time, prepared and ready to play.
- I help to create a positive rehearsal and concert environment.

PARENT/CAREGIVER RESPONSIBILITIES

3. If misconduct escalates parent/caregivers will cooperate with NVYS as a collaborative partner to address musician's needs.

- 5. Provide a home environment that encourages regular practice.

NVYS STAFF RESPONSIBILITIES

Each NVYS and Sinfonia coach and staff has a fundamental role in supporting a positive environment which supports a rewarding and positive music education experience and assures that all musicians are safe, responsible and respectful. NVYS staff is responsible for:

1. Defining and reviewing and NVYS Code of Behavior with the musicians.

2. Acknowledging and reinforcing appropriate musician behavior.

3. Contacting families in a timely manner to discuss chronic misbehavior or behavior that is unsafe to the musician or others.

4. Suspending musician participation without reimbursement of tuition if musician puts self or others in physical danger to keep all musicians safe.
